Processing Time:

Up to 60 days for processing in Indonesia.

Documents required:

- Original passport valid minimum 36 Months
- Document showing family ties to Primary Kitas holder (marriage certificate or birth certificate)
- Bank statement (minimum amount \$1500)
- Address in original country.
- Address in Indonesia (hotel or villa).
- Domicile Letter Address in Bali (if any) or Lease Agreement Letter
- Scanning passport of Primary KITAS/KITAP holder (Husband/Parent)
- KITAS/KITAP of Primary KITAS holder (Husband/Parent)
- Scanning document of Primary KITAS/KITAP holder Company Sponsor
- Limited Stay Permit card (KITAS) proofing that the relevant foreigner has been staying for 5 (Five) consecutive years in territory of Indonesia
- SKTT (Residence Certificate)
