FOREIGN INVESTMENT KITAS - OFFSHORE

IDR 20.000.000

Valid for 2 years, includes multiple entry permit sponsorship. This does not include:

- **USD 150** Indonesia Embassy visa application fee.
- PayPal fees 5%

Option 1 Year Foreign Investment KITAS - **IDR 16.000.000**

Processing Time:

Up to 40 business days for processing in Indonesia.

There is an option up to 30 business days of express service for additional fees.

E-Visa Fee (**IDR 2.000.000**)

E-KITAS Express Fee (**IDR 2.000.000**)

Documents required:

- Scanning Passport full page 1 (Identity Page) and cover (No photos & in color)
- Passport valid for at least 30 months for 2 years KITAS and 18 months for 1 year KITAS minimum 2 blank pages.
- Address in Original Country
- Address in Bali (hotel/villa)
- Domicile Letter Address in Bali (if any) or Lease Agreement Letter
- Personal Phone number & Email
- Offshore Application - Full Dose Vaccine Certificate required
- Emergency Contact Person (Family Members), Address, Phone Number, Email
- PMA (Foreign Investment Company) Company Document
- Minimum Capital on PMA **IDR 1.125.000.000**
- Formal Photo

Process:

1. Register PMA Company to Indonesian Visa Online System
2. Apply E-Visa C314
3. E-Visa C314
4. Process E-Visa E-Visa C314 to KITAS C314 to the Local Immigration

Renewal:

- Renewal for 2 years and the cost **IDR 17.500.000** but you do not need to fly out and apply for the visa at Indonesian Embassy outside of Indonesia. And no cost for Indonesia Embassy visa application fee.
- Renewal will be for 1 year and the cost **IDR 12.500.000** but you do not need to fly out and apply for the visa at Indonesian Embassy outside of Indonesia. And no cost for Indonesia Embassy visa application fee.
- Renewal needs to be process within 1 - 3 months before your KITAS Expired.
- You are required to be inside Indonesia to process any KITAS renewal.
- Document required:
 - Domicile Letter/SKTT

Please note:

* Payment can be done via PayPal or Bank Transfer.

** Prices are as per the date on the document.

*** Processing will begin once funds are clear in our account

**** Price does not include SKTT or NIK document

After you receive the E-Visa (Offshore Application)

Follow the steps:

Step 1

Please print out the sponsorship and E-Visa for Entering Indonesia

Step 2

Upon arrival to Indonesia you will need to present us with your passport within 30 days. We then take it to the local immigration office to show them your visa for final approval. You will also be required to attend during this process for Biometrics.

EPO/KITAS Cancellation

If you do not continue or extending your KITAS you need to processing EPO and the Cost **IDR 1.000.000**

PMA (Foreign Investment Company) Sponsor Documents Requirement:

1. Company deed of establishment and its amendments (*if any*)
2. Approval from the Ministry of Law and Human Rights (MoLHR) of company sponsor
/SK Kehakiman Pendirian Perusahaan dan Perubahannya (if any)
3. Tax Registration Number (NPWP) of company sponsor
4. NIB (Business Registration Number) - OSS
5. Ijin Lokasi/PKKPR (Location Permit) - OSS
6. Ijin Usaha (SIUP)/Standard Certificate/SPPL (Business License) - OSS
7. ID Card (KTP) and Family Register (KK) of the Indonesian Director of company sponsor as Guarantor, or passport of foreign Director.
8. Blank papers with the company's letterhead and Company Stamp.
9. Visa Onlie Log-in (if any)
