SPOUSAL FAMILY KITAS - OFFSHORE

IDR 10.000.000

Valid for 1 year, includes multiple entry permit.

Valid for 6 months includes multiple entry permit **IDR 9.000.000**

This does not include:

- **USD 150** Indonesia visa application fee.
- PayPal fees 5%

Processing Time:

30 to 40 days for processing in Indonesia.

There is an option for up to 30 business days of express service for additional fees. E-Visa Express Fee (**IDR 2.000.000**)

E-KITAS Express Fee (**IDR 2.000.000**)

Documents required:

- Passports valid for at least 18 months and minimum 2 blank pages.
- Scanning of the main page of the passport details
- Scanning of the page of the passport cover
- Bank Statement (Minimum Amount USD 1.500)
- Address in Original Country
- Address in Indonesia (hotel/villa)
- ID Card (KTP) of Indonesian spouse
- Family Card (Kartu Keluarga) of Indonesian spouse
- Birth Certificate (Akta Lahir) of Indonesian spouse
- Marriage Certificate (already reported to civil registration in Indonesia),
If married outside Indonesia:
 - Marriage Certificate Original (Certificate must be translated in English/Bahasa Indonesia)
 - Marriage Certificate report from Indonesian Embassy
- Domicile Letter Address in Bali (if any) or Lease Agreement Letter
- Offshore Application - Full Dose Vaccine Certificate required
- Formal Photo

Process:

1. Register Indonesian Spouse to Indonesian Visa Online System
2. Apply E-Visa C317
3. E-Visa C317
4. Process E-Visa C317 to KITAS C317 at the Local Immigration

Renewal:

- Renewal every year cost **IDR 8.000.000**, you do not need to fly out and apply for the visa at Indonesian Embassy outside of Indonesia. And no cost for Indonesia Embassy visa application fee.
- Renewal every 6 months cost **IDR 7.500.000**, you do not need to fly out and apply for the visa at Indonesian Embassy outside of Indonesia. And no cost for Indonesia Embassy visa application fee.
- Renewal needs to be process within 1 - 3 months before your KITAS Expired.
- You are required to be inside Indonesia to process any KITAS renewal.
- Document required:
 - Domicile Letter/SKTT

Please note:

*Payment can be done via PayPal or Bank Transfer.

After you receive the E-Visa (Offshore Application)

Follow the steps:

Step 1

Please print out the sponsorship and E-Visa for Entering Indonesia

Step 2

Upon arrival to Indonesia you will need to present us with your passport within 30 days. We then take it to the local immigration office to show them your visa for final approval. You will also be required to attend during this process for Biometrics.

EPO/KITAS Cancelation

If you do not continue or extending your KITAS you need to processing EPO and the Cost **IDR 1.000.000**
