## Ex Indonesian Citizen

A person who was previously an Indonesian and has acquired citizenship of another country, who will stay for 1 year, 2 years or 5 years in Indonesia by fulfilling the immigration guarantee.

| Other information | $\checkmark$ If you meet the conditions, you will automatically obtain the electronic limited stay permit (e-ITAS) and the Re-Entry Permit upon arrival at the Immigration Checkpoint (you do not need to go to the immigration office to obtain a Limited Stay Permit and Re-Entry Permit). <br> $\checkmark$ In addition to the electronic limited stay permit, the limited stay permit also has a physical card available at the immigration office. <br> $\checkmark \quad$ Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges. |
| General Requirements | $\checkmark \quad$ Valid Nationality Passport at least 12 (twelve) months. <br> $\checkmark \quad$ Proof of living expenses of at least USD $\$ 2000$ (two thousand American dollars) or equivalent for the last 3 months period (including name, date of period, and balance account). <br> $\checkmark$ Latest color photograph. <br> $\checkmark$ Document that proves that the Foreigner has been an Indonesian citizen, among others: <br> - Identity card (KTP); <br> - Birth certificate; <br> - Family card (KK); <br> - Passport of the Republic of Indonesia; <br> - Diploma, or <br> - Land certificate. <br> $\checkmark$ Additional documents required according to duration of stay permit |
| Visa Validity | $\checkmark \quad$ This visa must be used within 90 days from the date of issue. <br> $\checkmark \quad$ Please note that the visa validity period of the visa is different from the period of stay, kindly check your visa for the period of stay Information. |
