



## E32 – EX INDONESIAN CITIZEN

### Ex Indonesian Citizen

A person who was previously an Indonesian and has acquired citizenship of another country, who will stay for 1 year, 2 years or 5 years in Indonesia by fulfilling the immigration guarantee.

<b>Stay</b>	Up to 1 Year, 2 Years or 5 Years
<b>Processing time</b>	Up to 40 Business Days
<b>With this visa you can</b>	<ul style="list-style-type: none"> <li>✓ Conducting activities related to tourism, and visiting friends or family.</li> <li>✓ Travel to and from Indonesia.</li> <li>✓ Carry out employment-related activities or attending education, as long as it has been reported to Immigration (using the multiple activity reporting process).</li> </ul>
<b>You must</b>	<ul style="list-style-type: none"> <li>✓ Be financially sufficient during your stay in Indonesia.</li> <li>✓ Comply with all visa conditions and Indonesia laws.</li> <li>✓ Report on the compliance of commitments within 90 days after the date of entry.</li> </ul>
<b>Other information</b>	<ul style="list-style-type: none"> <li>✓ If you meet the conditions, you will automatically obtain the electronic limited stay permit (e-ITAS) and the Re-Entry Permit upon arrival at the Immigration Checkpoint (you do not need to go to the immigration office to obtain a Limited Stay Permit and Re-Entry Permit).</li> <li>✓ In addition to the electronic limited stay permit, the limited stay permit also has a physical card available at the immigration office.</li> <li>✓ Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.</li> </ul>
<b>General Requirements</b>	<ul style="list-style-type: none"> <li>✓ Valid Nationality Passport at least 12 (twelve) months.</li> <li>✓ Proof of living expenses of at least USD \$2000 (two thousand American dollars) or equivalent for the last 3 months period (including name, date of period, and balance account).</li> <li>✓ Latest color photograph.</li> <li>✓ Document that proves that the Foreigner has been an Indonesian citizen, among others:               <ul style="list-style-type: none"> <li>■ Identity card (KTP);</li> <li>■ Birth certificate;</li> <li>■ Family card (KK);</li> <li>■ Passport of the Republic of Indonesia;</li> <li>■ Diploma, or</li> <li>■ Land certificate.</li> </ul> </li> <li>✓ Additional documents required according to duration of stay permit</li> </ul>
<b>Visa Validity</b>	<ul style="list-style-type: none"> <li>✓ This visa must be used within 90 days from the date of issue.</li> <li>✓ Please note that the visa validity period of the visa is different from the period of stay, kindly check your visa for the period of stay Information.</li> </ul>
