<b>Stay</b>	Up to 1 Years
<b>Cost</b>	IDR 10.000.000 + USD \$150
<b>Processing time</b>	Up to 40 Business Days
<b>With this visa you can</b>	<ul style="list-style-type: none"><li>✓ Carry out activities related to business, meetings, or purchase of goods including but not limited to checking goods at the office, factory, or production site of goods.</li><li>✓ Bring eligible family to live in Indonesia.</li><li>✓ Travel to and from Indonesia.</li><li>✓ Conducting activities related to tourism, and visiting friends or family.</li></ul>
<b>You must</b>	<ul style="list-style-type: none"><li>✓ Comply with laws and regulations.</li><li>✓ Respect local customs, culture, and wisdom.</li><li>✓ Have sufficient living expenses while in Indonesia.</li></ul>
<b>Other information</b>	<ul style="list-style-type: none"><li>✓ Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.</li><li>✓ In addition to the electronic limited stay permit, the limited stay permit also has a physical card available at the immigration office.</li><li>✓ You are prohibited from selling goods or services.</li><li>✓ You are prohibited from working by receiving compensation, wages, or any similar from individuals or companies in Indonesia.</li></ul>
<b>Document Requirements</b>	<ul style="list-style-type: none"><li>✓ Valid Nationality Passport at least 6 (six) months.</li><li>✓ Personal bank statement with minimum amount USD \$2000 or equivalent the last 3 months period (including name, date of period, and balance account).</li><li>✓ Recent photograph.</li><li>✓ Guarantee from the guarantor.</li><li>✓ Bank account proving income or allowance with a value of USD \$3,000 per month.</li></ul>
<b>Visa Validity</b>	<ul style="list-style-type: none"><li>✓ This visa must be used within 90 days from the date of issue.</li><li>✓ Please note that the visa validity period of the visa is different from the period of stay, kindly check your visa for the period of stay Information.</li></ul>
