### Kitas for foreign dependent of an Indonesian

Joining family members residing in the territory of Indonesia.

<b>Stay</b>	Up to 6 Months or 1 Year.
<b>Processing time</b>	✓ Up to 40 business days.
<b>Document Requirements</b>	
<b>From applicant</b>	<ul style="list-style-type: none"> <li>✓ Bali Visas application form.</li> <li>✓ Scan of the identity and signature pages of passport (no photos, must be a color scan).</li> <li>✓ Passport valid for at least 18 months with a minimum of 2 blank pages.</li> <li>✓ Scan of most recent visa sticker/stamp in passport; a minimum of 30 days validity is required during the process to avoid overstay.</li> <li>✓ Recent passport-style color photo (digital format).</li> <li>✓ Akta Nikah/ Marriage Certificate (already reported to civil registration in Indonesia).</li> <li>✓ If married outside Indonesia: <ul style="list-style-type: none"> <li>■ Original Marriage Certificate (certificate must be translated in English or Bahasa Indonesia).</li> <li>■ Marriage certificate report from Indonesian embassy.</li> </ul> </li> <li>✓ Company's Bank statement (minimum amount USD \$2,000).</li> <li>✓ Document showing family ties to Primary KITAS holder (Marriage Certificate or Birth Certificate): <ul style="list-style-type: none"> <li>■ Spousal (Marriage Certificate) must be in English/ Bahasa Indonesia.</li> <li>■ Kids under 17 years old (Marriage &amp; Birth Certificate) must be in English/ Bahasa Indonesia.</li> </ul> </li> <li>✓ Sponsor transfer letter (required if current visa is not sponsored by Bali Visas).</li> <li>✓ ID Card of the previous guarantor or sponsor is required.</li> <li>✓ Single Entry E-Visa.</li> </ul>
<b>From spouse (If foreign citizen)</b>	<ul style="list-style-type: none"> <li>✓ Scan of the identity and signature pages of passport (no photos, must be a color scan).</li> <li>✓ Scan of Kitas.</li> </ul>
<b>From foreign spouse's Indonesian employer/ sponsor:</b>	<ol style="list-style-type: none"> <li>1. Company deed of establishment and its amendments.</li> <li>2. Approval from the Ministry of Law and Human Rights (MoLHR) of company sponsor.</li> <li>3. Tax Registration Number (NPWP) of company sponsor.</li> <li>4. OSS documents (NIB, Ijin Lokasi, Ijin Usaha)</li> <li>5. Indonesian ID Card (KTP) and Family Card (Kartu Keluarga) of the Indonesian director of company sponsor as guarantor, or passport of foreign director.</li> <li>6. Company letterhead and company stamp.</li> <li>7. Login TKA Online &amp; Visa Online (If company has been registered)</li> </ol>

### Note:

- Domicile letter is only required upon Kitas renewal or address change (prices does not include variable Banjar donation).
- SKTT is only required upon Kitas renewal or purchase of vehicle.

### Kitas cancelation:

You are required to cancel your Kitas if you want to terminate it or change to a new visa:

- EPO (Exit Permit Only) is required if you are inside Indonesia.
- ERP (Exit Re-Entry) Permit is required if you are outside of Indonesia

**Kitas renewal:**

- Annual renewal price: **IDR 8.000.000.**
- Applicant must be physically present in Indonesia to process Kitas renewal.
- Renewal needs to be processed within 1 - 3 months before your Kitas expires.
- Documents required:
  - Passport.
  - Domicile letter of home address.
  - SKTT (Temporary Residential Registration).

\*\*\*Processing of your application will commence only after the funds have successfully cleared into our account.
