



SINGLE ENTRY VISA (INDEX C)

A Single-Entry Visit Visa permits a single entry, meaning once you leave the country, a new visa will be required for re-entry. Depending on the type, a stay of 30, 60 or 180 days is permitted.

Length of Stay	→ 30 days (not extendable) → 60 days (extendable 2x, MAX 180 days) → or 180 days (extendable 1x)
Processing Time	→ Regular takes up to 14 business days. → Priority takes up to 5 business days.

With this visa you CAN NOT	☒ Perform PAID work. ☒ Exit and re-enter Indonesia. ☒ Stay in Indonesia after your visa expires.
Visa validity	This visa must be used within 90 days from the date of issue.
General Requirements	→ Passport that is valid for at least 6 (six) months. → A recent color photograph. → Personal bank statement with minimum amount USD \$2,000 (stay up to 30 and 60 days) or USD \$5,000 (stay up to 180 days) or equivalent for the last 3 months period (including name, date of period, and balance account).
