



RETIREMENT KITAP

(Permanent Stay Permit)

Suitable for foreigners who have held a Retirement KITAS for at least four years. It is valid for five years and is extendable for a lifetime. Additionally, if you plan to travel abroad and return to Indonesia, you will need a Multiple Re-entry Permit (MERP) after two years. The MERP is valid for two years and allows you to re-enter Indonesia.

With this visa you CAN	<ul style="list-style-type: none">✓ Live in Indonesia for five years, with the possibility of extension.✓ Travel in and out of Indonesia multiple-entry permit/ MERP (valid for 2 years).✓ Have stable residency status for five years, with the possibility of extension.✓ Be eligible for a local ID card (KTP-OA), facilitating easier access to services and amenities.✓ Participate in non-profit activities such as voluntary work, hobbies, and social activities.
With this visa you CAN NOT	<ul style="list-style-type: none">✗ Stay in Indonesia after your visa expires.✗ Work or be employed in Indonesia.✗ Negate the financial requirements such as proof of income and health insurance.
General Requirements	From applicant: <ul style="list-style-type: none">→ Bali Visas application form.→ Original passport valid for a minimum of 36 months.→ A minimum of 3 months KITAS validity is required upon submission to immigration.→ Bank statement (minimum amount USD \$1.500).→ Domicile letter of home address in Bali and copy of lease agreement.→ Life or health insurance policy.→ Maid/ helper ID card (KTP).→ Limited Stay Permit Card (KITAS) proving that the applicant has lived in Indonesia for the last 3 (three) consecutive years.→ SKTT (Temporary Residential Registration).

Requirements	<ul style="list-style-type: none">→ Applicant must be physically present in Indonesia to process Kitap renewal.→ Renewal needs to be processed within 1 - 3 months before your Kitap expires.
