

WORKING KITAP

(Permanent Stay Permit)

Available for foreigners who have worked as a Board of Directors (BOD) or Commissioner (BOC) for an Indonesian company on a Working KITAS for at least three years. You must apply for this KITAP from within Indonesia. It is valid for five years and can be extended for a lifetime. Additionally, if you plan to travel abroad and return to Indonesia, you will need a Multiple Re-entry Permit (MERP) after two years. The MERP is valid for two years and allows you to re-enter Indonesia.

Length of Stay	5 years
Processing Time	→ Regular takes up to 60 business days.
With this visa you CAN	 Live in Indonesia for five years, with the possibility of extension. Travel in and out of Indonesia with multiple-entry permit/ MERP (valid for 2 years). Work in Indonesia (requires a work permit for the specific job). Engage in social, cultural, educational, and familial activities.
With this visa you CAN	☑ Stay in Indonesia after your visa expires.
NOT	☑ Engage in any work or job outside of that which is associated with your Kitap.
General Requirements	 From applicant: Bali Visas application form. Original passport valid for a minimum of 36 months. A minimum of 3 months Kitas validity is required upon submission to immigration. Recent passport-style color photo (digital format). Copy of University Degree Certificate or relevant qualification/ experience. Place of work in Indonesia (Region). Job title/ position. Limited Stay Permit card (KITAS) proving that the applicant has lived in Indonesia for the last 3 years. SKTT (Temporary Residential Registration).

	Company deed of establishment and its amendments.
	→ Approval from the Ministry of Law and Human Rights (MoLHR) of company.
	→ Tax Registration Number → (NPWP) of company.
	→ OSS documents (NIB, Ijin Lokasi, Ijin Usaha).
	→ Copy of shareholders passport or Indonesian ID card (KTP).
	→ Company letterhead and company stamp.

Requirements	 → Applicant must be physically present in Indonesia to process Kitap renewal. → Renewal needs to be processed within 1 - 3 months before your Kitap expires.
