



## E31 – DEPENDENT KITAS OF INDONESIAN CITIZEN (FAMILY KITAS)

Family members of Indonesian citizens are permitted to reside in Indonesia as dependents of their sponsoring Indonesian family member.

<b>General Requirements</b>	<ul style="list-style-type: none"><li>➔ Passport that is valid for at least 6 (six) months.</li><li>➔ A recent color photograph.</li><li>➔ A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.</li><li>➔ Valid visa/Limited Stay Permit (ITAS)/Permanent Stay Permit (ITAP) of the legitimate husband or wife.</li><li>➔ ITK/ Permit Number (<i>Applying from within Indonesia</i>)</li></ul>
<b>Additional Requirements</b>	<p><b>Spouse of Indonesian Citizen:</b></p> <ul style="list-style-type: none"><li>➔ Marriage certificate translated into Indonesian by a sworn translator.</li><li>➔ Application from husband or wife (Indonesian citizen).</li></ul> <p><b>Child of Indonesian Citizen &amp; Stepchild of Indonesian Citizen:</b></p> <ul style="list-style-type: none"><li>➔ Family card of Indonesian parent.</li><li>➔ Visa Application from Indonesian parent.</li><li>➔ Birth certificate translated into Indonesian by a sworn translator.</li><li>➔ Marriage certificate translated into Indonesian by a sworn translator.</li></ul> <p><b>An Adopted Child of Indonesian Citizen:</b></p> <ul style="list-style-type: none"><li>➔ Family card of Indonesian parent.</li><li>➔ Visa Application from Indonesian parent.</li><li>➔ Indonesian court decisions that explain the status of the legal relations between Foreigners with Indonesian parent.</li></ul> <p><b>Parent of Indonesian Citizen:</b></p> <ul style="list-style-type: none"><li>➔ Visa Application from an Indonesian citizen (child of the foreigner).</li><li>➔ Proof of the legal relationship between parents and children as shown by the child's family card.</li><li>➔ Birth certificate translated into Indonesian by a sworn translator.</li></ul>

Document Requirements	➔ Passport that is valid for at least 18 (eighteen) months. ➔ A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.
Requirements	➔ Applicant must be physically present in Indonesia to process KITAS renewal. ➔ Renewal needs to be processed within 1 month before your KITAS expires.
