



E33F – RETIREMENT VISA (RETIREMENT KITAS)

The Retirement Kitas is available for foreign nationals aged 55 and above who wish to retire in Indonesia. Applicants must show proof of sufficient funds to support their stay. This visa is valid for 1 year and can be renewed. Holders of this visa are not allowed to work.

Visa validity	This visa must be used within 90 days from the date of issue.
General Requirements	→ Passport that is valid for at least 6 (six) months. → A recent colour photograph. → A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance. → Proof of income of a minimum equivalent amount of USD \$3,000 per month. → Life or Health Insurance. → ID Maid (<i>Applying from within Indonesia</i>) → Lease Agreement (<i>Applying from within Indonesia</i>) → ITK/ Permit Number (<i>Applying from within Indonesia</i>)

Document Requirements	→ Passport that is valid for at least 18 (eighteen) months. → A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.
Requirements	→ Applicant must be physically present in Indonesia to process Kitas renewal. → Renewal needs to be processed within 1 month before your Kitas expires.
Price	→ IDR 8.500.000 (Stay 6 months). → IDR 12.000.000 (Stay 1 year). → IDR 15.000.000 (Stay 2 years).
