

# **E33F – RETIREMENT VISA**

(RETIREMENT KITAS)

The Retirement Kitas is available for foreign nationals aged 55 and above who wish to retire in Indonesia. Applicants must show proof of sufficient funds to support their stay. This visa is valid for 1 year and can be renewed. Holders of this visa are not allowed to work.

<ul> <li>Conduct activities related to tourism, and visiting friends or family.</li> <li>Bring eligible family to live in Indonesia.</li> <li>Travel to and from Indonesia.</li> </ul>			
<ul><li>Stay in Indonesia after your visa expires.</li><li>Work for and earn money from an Indonesian entity.</li></ul>			
This visa must be used within 90 days from the date of issue.			
<ul> <li>Passport that is valid for at least 6 (six) months.</li> <li>A recent colour photograph.</li> <li>A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.</li> <li>Proof of income of a minimum equivalent amount of USD \$3,000 per month.</li> <li>Life or Health Insurance.</li> <li>ID Maid (Applying from within Indonesia)</li> <li>Lease Agreement (Applying from within Indonesia)</li> <li>ITK/ Permit Number (Applying from within Indonesia)</li> </ul>
