



WORKING KITAP (Permanent Stay Permit)

Available for foreigners who have worked as a Board of Directors (BOD) or Commissioner (BOC) for an Indonesian company on a Working KITAS for at least three years. You must apply for this KITAP from within Indonesia. It is valid for five years and can be extended for a lifetime. The MERP is valid for 5 years and allows you to re-enter Indonesia.

With this visa you CAN NOT	<ul style="list-style-type: none">☑ Stay in Indonesia after your visa expires.☑ Engage in any work or job outside of that which is associated with your Kitap.
General Requirements	<p>From applicant:</p> <ul style="list-style-type: none">→ Bali Visas application form.→ Original passport valid for a minimum of 36 months.→ A minimum of 3 months Kitas validity is required upon submission to immigration.→ Recent passport-style color photo (digital format).→ Copy of University Degree Certificate or relevant qualification/ experience.→ Place of work in Indonesia (Region).→ Job title/ position.→ Limited Stay Permit card (KITAS) proving that the applicant has lived in Indonesia for the last 3 years.→ SKTT (Temporary Residential Registration). <p>From company (PMA):</p> <ul style="list-style-type: none">→ Company deed of establishment and its amendments.→ Approval from the Ministry of Law and Human Rights (MoLHR) of company.→ Tax Registration Number→ (NPWP) of company.→ OSS documents (NIB, Ijin Lokasi, Ijin Usaha).→ Copy of shareholders passport or Indonesian ID card (KTP).→ Company letterhead and company stamp.→ Login TKA Online & Visa→ Online (If company has been registered).
