A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance. Evidence of share ownership of at least Rp10,000,000,000.00 (ten billion rupiah) or equivalent in the guarantor company listed in the Ministry of Investment / Indonesia Investment Coordinating Board. Ministry of Law and Human Rights Decree regarding the legalization of the establishment the company. Company current account for the last 2 (two) months. ITK/ Permit Number (Applying from within Indonesia)
