



E31 – GOLDEN VISA FOR DEPENDENT FAMILY

Dependent family members of KITAS and long-stay visa holders (including Golden and Remote Worker Visas) are allowed to reside in Indonesia as dependents of their sponsoring family member.

General Requirements	→ Passport that is valid for at least 6 (six) months. → A recent color photograph. → A personal bank statement showing a minimum equivalent amount of USD \$2000. The statement must cover the last 3 months and include your name, the date, and the account balance. → Valid visa/Limited Stay Permit (ITAS)/Permanent Stay Permit (ITAP) of the legitimate husband or wife. → ITK/ Permit Number (<i>Applying from within Indonesia</i>)
Additional Requirements	→ Marriage certificate translated into Indonesian by a sworn translator (Spouse Golden Visa). → Birth certificate translated into Indonesian by a sworn translator (Child Golden Visa). → Marriage book or parents' marriage certificate translated into Indonesian (Child Golden Visa). → Proof of medical condition or proof of guardianship translated into Indonesian by a sworn translator* (specifically for individuals above 18 years old with humanitarian/health considerations) (Child Golden Visa). → The child's birth certificate has been translated into Indonesian by a sworn translator (Parent Golden Visa).

Length of Stay	5 years or 10 years
Processing Time	14 business days.
Document Requirements	→ Passport that is valid for at least 18 (eighteen) months. → A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.
Requirements	→ Applicant must be physically present in Indonesia to process Kitas renewal. → Renewal needs to be processed within 1 - 3 months before your Kitas expires.
Price	→ IDR 35.250.000 (Stay 5 years). → IDR 50.250.000 (Stay 10 years).
