



E33G – REMOTE WORKER VISA (DIGITAL NOMAD VISA)

This Digital nomad visa is designed for remote workers who wish to live in Indonesia while working for foreign companies. This visa is valid for up to 1 year and is renewable.

With this visa you CAN	☒ Carry out assignments for an overseas company. ☒ Travel to and from Indonesia as long as your permit is valid. ☒ Conduct activities related to tourism, and visiting friends or family
With this visa you CAN NOT	☒ Stay in Indonesia after your visa expires. ☒ Sell goods or services within Indonesia. ☒ Receive compensation, wages, or similar from Indonesian companies or entities.
Visa validity	This visa must be used within 90 days from the date of issue.
General Requirements	→ Passport that is valid for at least 6 (six) months. → A recent color photograph. → Personal bank statement with a minimum balance of USD \$2,000 (Offshore) or USD \$5,000 (Onshore) equivalent for the last 3 months period (including name, dates and corresponding balances). → Proof of annual income of an amount equivalent to 60,000 USD. → Remote worker employment contract with overseas company. → Certificate of incorporation of employing company. → Travel itinerary while in Indonesia → CV (Curriculum Vitae) → ITK/ Permit Number (<i>Applying from within Indonesia</i>).

Document Requirements	→ Passport that is valid for at least 18 (eighteen) months. → A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.
Requirements	→ Applicant must be physically present in Indonesia to process KITAS renewal. → Renewal needs to be processed within 1 month before your KITAS expires.
