(DIGITAL NOMAD VISA)

This Digital nomad visa is designed for remote workers who wish to live in Indonesia while working for foreign companies. This visa is valid for up to 1 year and is renewable.

General Requirements	<ul> <li>Passport that is valid for at least 6 (six) months.</li> <li>A recent color photograph.</li> <li>Personal bank statement with a minimum balance of USD \$2,000 (Offshore) or USD \$5,000 (Onshore) equivalent for the last 3 months period (including name, dates and corresponding balances).</li> <li>Proof of annual income of an amount equivalent to 60,000 USD.</li> <li>Remote worker employment contract with overseas company.</li> <li>Certificate of incorporation of employing company.</li> <li>Travel itinerary while in Indonesia</li> <li>CV (Curriculum Vitae)</li> <li>ITK/ Permit Number (Applying from within Indonesia).</li> </ul>
