



## E28A – INVESTOR KITAS (General Investment)

The Investor KITAS is available to foreigners wanting to invest or establish a company in Indonesia. This visa allows multiple entries and is valid for, and permits a continuous stay of up to 2 years.

| Visa validity                     | This visa must be used within 90 days from the date of issue.  |
| General Requirements              | <ul style="list-style-type: none"><li>➔ PMA (Foreign Investment Company) company document</li><li>➔ Passport that is valid for at least 6 (six) months.</li><li>➔ A recent color photograph.</li><li>➔ A personal bank statement showing a minimum equivalent amount of USD \$2,000. The statement must cover the last 3 months and include your name, the date, and the account balance.</li><li>➔ Evidence of share ownership of at least Rp10,000,000,000.00 (ten billion rupiah) or equivalent in the guarantor company listed in the Ministry of Investment / Indonesia Investment Coordinating Board.</li><li>➔ Ministry of Law and Human Rights Decree regarding the legalization of the establishment the company.</li><li>➔ Company current account for the last 2 (two) months.</li><li>➔ ITK/ Permit Number (<i>Applying from within Indonesia</i>)</li></ul> |
