



## MULTIPLE ENTRY VISA (INDEX D)

Multiple entry visas are available for 1, 2 or 5 years. Periods of stay for this visa allow either 60 days per visit (but can be extended twice) OR 180 days per visit (but can be extended once). With a multi entry visa, you may exit and re-enter the country under the same visa.

<b>Length of Stay</b>	60 days (extendable 2x, MAX 180 days) or 180 days (extendable 1x, 180 days)

<b>Visa validity</b>	1, 2 or 5 years.
<b>General Requirements</b>	<ul style="list-style-type: none"> <li>→ Passport that is valid for at least 6 (six) months.</li> <li>→ A recent color photograph.</li> <li>→ Personal bank statement with minimum amount USD \$2,000 (stay up to 60 days) or USD \$5,000 (stay up to 180 days) or equivalent for the last 3 months period (including name, date of period, and balance account).</li> <li>→ Statement of Commitment Form. (For D12-Pre-Investment Visa only)</li> </ul>
