



E23 – WORKING KITAS (Employment)

A working KITAS allows you to work for and earn money from an Indonesian company. The role and specific duties must be in accordance with those designated by the Labor Department.

The statement must cover the last 3 months and include your name, the date, and the account balance. → ITK/ Permit Number (<i>Applying from within Indonesia</i>)
Document requirements for the employer	<ul style="list-style-type: none"> → Indonesian company formation documents. → ID card of accompanying local workers (Tenaga Kerja Indonesia/TKI). → Salary amount. → Employment contract → Work location and confirmation of office presence if the location is outside the company's registered address. → WLKP (Mandatory Labor Reporting) account information. → NPP BPJS Ketenagakerjaan (BPJS Ketenagakerjaan registered number).

Requirements	<ul style="list-style-type: none"> → Applicant must be physically present in Indonesia to process KITAS renewal. → Renewal needs to be processed within 1 month before your KITAS expires.
