



## E32 – EX-INDONESIAN (GOLDEN VISA - DIASPORA)

The Ex-Indonesian Golden Visa is for former Indonesian citizens and their foreign children. E32 A/B Visa holders can also apply for family visas for their spouses, or parents.

**E32A – Ex-Indonesian Citizen 5 years**

**E32B – Descendant of An Ex-Indonesian 5/10 years**

Information	Description
<b>Length of Stay</b>	5 years or 10 years
<b>Processing Time</b>	→ Regular takes up to 60 business days.
<b>With this visa you CAN</b>	<input checked="" type="checkbox"/> Bring eligible members of your family. <input checked="" type="checkbox"/> Conducting activities related to tourism, and visiting friends or family. <input checked="" type="checkbox"/> Travel to and from Indonesia.
<b>With this visa you CAN NOT</b>	<input checked="" type="checkbox"/> Work or be employed by an Indonesian company.
<b>With this visa you MUST</b>	→ Report on the compliance of commitments within 90 days after the date of entry
<b>Visa validity</b>	This visa must be used within 90 days from the date of issue.
<b>General Requirements</b>	<ul style="list-style-type: none"> <li>→ Passport that is valid for at least 6 (six) months.</li> <li>→ A recent color photograph.</li> <li>→ A personal bank statement showing a minimum equivalent amount of US \$2000. The statement must cover the last 3 months and include your name, the date, and the account balance.</li> <li>→ ITK/ Permit Number (<i>Applying from within Indonesia</i>)</li> </ul>
<b>Additional Documents</b>	<p><b>Ex-Indonesian Citizen (E32A) – 5 Years</b></p> <ul style="list-style-type: none"> <li>→ Statement of commitment to purchase one of the following:               <ul style="list-style-type: none"> <li>✓ Indonesian Government bonds of at least US \$25,000.</li> <li>✓ Shares in listed companies in Indonesia of at least US \$25,000.</li> <li>✓ Mutual funds in publicly listed companies in Indonesia of at least US \$25,000.</li> </ul> </li> <li>→ Documents that prove the applicant has been an Indonesian citizen such as:               <ul style="list-style-type: none"> <li>✓ Identity card (KTP);</li> <li>✓ Birth certificate;</li> <li>✓ Family card (KK);</li> <li>✓ Passport of the Republic of Indonesia;</li> <li>✓ Diploma, or</li> <li>✓ Land certificate.</li> </ul> </li> <li>→ A statement of commitment to retain the value of the Immigration Guarantee of US \$25,000, which is a requirement for visa application while the Stay Permit is valid.</li> <li>→ These obligations must be fulfilled no later than 90 days after the ITAS is granted.</li> </ul> <p><b>Second-degree Ex-Indonesian Citizens (E32B) – 5/10 Years</b></p> <ul style="list-style-type: none"> <li>→ Statement of commitment to purchase one of the following:               <ul style="list-style-type: none"> <li>✓ Indonesian Government bonds of US \$30,000 for 5 years length of stay or US \$60,000 for 10 years length of stay.</li> <li>✓ Shares in listed companies in Indonesia of at least US \$30,000 for 5 years length of stay or US \$60,000 for 10 years length of stay.</li> <li>✓ Mutual funds in publicly listed companies in Indonesia of at least US \$30,000 for 5 years length of stay or US \$60,000 for 10 years length of stay.</li> </ul> </li> <li>→ A statement of commitment to retain the value of the Immigration Guarantee of US \$30,000 for 5 years length of stay or US \$60,000 for 10 years length of stay, which is a requirement for visa application while the Stay Permit is valid.</li> <li>→ Documents that prove the applicant first or second degree of an Indonesian citizen such as:               <ul style="list-style-type: none"> <li>✓ Birth certificate;</li> <li>✓ Family card (KK) or</li> <li>✓ Marriage certificate.</li> </ul> </li> <li>→ These obligations must be fulfilled no later than 90 days after the ITAS is granted.</li> </ul>

### Renewal:

Information	Description
Length of Stay	5 years or 10 years
Processing Time	40 business days.
Document Requirements	→ Passport that is valid for at least 6 (six) months. → Proof of living expenses of at least USD 2,000 (two thousand US Dollars) or equivalent
Requirements	→ Applicant must be physically present in Indonesia to process KITAS renewal. → Renewal needs to be processed within 1 - 3 months before your KITAS expires.
Price	→ <b>IDR 40.250.000 (Stay 5 years).</b> → <b>IDR 50.250.000 (Stay 10 years).</b>
