For a person aged 60 years or older who wishes to retire in Indonesia, this visa also enables your spouse, child, or parent to apply for a long-term visa, so you can be surrounded by loved ones.

Visa validity	This visa must be used within 90 days from the date of issue.
General Requirements	<ul style="list-style-type: none"> → Passport with a minimum validity of 6 months. → Proof of living costs min. US\$ 2,000. This refers to a recent bank statement. → Statement of commitment to deposit funds in an account in one's own name at a State-Owned Bank of at least US\$ 50,000, which must be fulfilled no later than 90 days after granting the ITAS at TPI. The balance of US\$ 50,000 has to be maintained during the whole period of visa validity. → Proof of income or benefits min. amount of US\$ 3,000. This refers to monthly pension payments, overseas business earnings or payments from individual entities.
